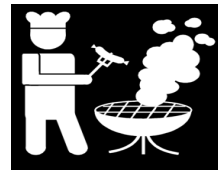
Brothers and Sisters, it is with regret that we must inform you of the passing of our Brother

JOBS REPORT

The work situation looks positive for the remainder of the year, with very few members looking for work.....please keep in mind Local 60 is still in need of electricians and apprentices in the coming months.

CTHBP

A bit of good news for the month ending May 2018, a net income of \$164,000.00, not much money, but nonetheless a net income. The fund currently has \$11,851,180.00 in total Liabilities and Reserves. Let's continue to live a healthy life. The contribution changes that took effect on June 1, 2018 will soon be reported...helping the total assets. Next meeting is scheduled for Sept, 2018

Local 60 Pension /401 (k):

Local 60 Pension Plan thru April of 2018 has net assets of \$58,585,000.00 and the Local 60 401(k) Plan has total net assets of \$19,700,000.00 as of current. The 401(k) employer contributions increased 1% June 1, 2018, from 4% to 5%.

Local 60 Dues Structure

When paying your union dues (currently \$38.00 a month), the PBF (international pension), International Death Benefit and participation in the Local Death Fund are all part of the benefits, approximately (\$20,000.00). Dues are due on or before the 10th of the current month for 2018) so that you are eligible for these benefits.
